The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant on Friday June 29TH 2018, at approximately 15:22, at 3122 MAHAN DR did the following violation of law:

FACTS TO SUPPORT ABOVE CHARGE(S): On Tuesday, June 29, 2018, I responded to 3122 Mahan Drive in reference to a theft incident. The call notes stated that a black male ran out of the store with a hand gun they had for sale and was not being cooperative in the manager's office.

I arrived at the above location with Officer Nastasi #540 and made contact with the store manager/reporting person (Marvin D. Crouch) in the manager's office. Also in the office was the arrestee (Jason F. White), who was sitting in a chair being verbally loud.

White, without provocation, said " I admit it, I stole the gun" and continued with the admission of guilt. White continued with his rant of "yeah I stole the gun and I admit I did it". White would not settle down and began to squirm in the chair while being verbally loud. He was placed into custody for the purpose of conducting the theft investigation and for the safety of the employees of Academy Sports.

According to Crouch, White came into the store and was observed going to the section of the store where firearms are sold. White asked the employee (Ben Boynton) if he could see one of the firearms that was located in the glass case. This firearm was a Glock model 27, ser #YVL446, and was handed over for the purpose showing the customer the firearm. Crouch was observing the transaction from a short distance and noticed that when White was handed the firearm, he ran and attempted to exit out of the front doors of the business. Crouch was instructed to stop White and ran after him making contact (tackling) just past the first doors and before the exit doors that lead to the parking lot. The gun flew out of White's hand and was recovered along with a backpack that contained other stolen merchandise (gun ammo and magazines (2)) from Academy Sports. The backpack itself was also stolen and still contained the store's price tag. White was then escorted back to the manager's office and the police were called to pursue charges of grand theft. The following items were stolen and in possession of White:

1. Glock model 27, ser #YVL446, .40 cal pistol valued at \$539.99.
2. Backpack (Hydration) valued at \$24.99.
3. Mon Brass (ammo) x5 Valued at \$84.95.
4. Glock Mag x2 valued at \$59.98.

All items total \$709.91.

Post Miranda, White again admitted to the theft and said he came into the store to get steal a gun because he wanted to do it. According to White, his family and kids were threatened by an unknown person and wanted a gun to "kill" him. He repeatedly said "I stole and I admit to it" and "I will steal again when I get out of jail".

White made additional statements that he was going to get out of jail today, steal again and will shoot someone.

White said we will see him on the evening news, just you wait and see.

He made additional threats to shoot "someone" even in our presence because he was not afraid to do so.

Crouch provided a sworn written statement of the theft, a receipt of the items stolen and the amount of each item along with the total that amounted to \$709.91. Additionally, Crouch stated that there was video of the theft however it can not be obtained at this time. It can be obtained later if needed for evidence and he will call when it will be available for pick up.

White was placed under arrest for grand theft, which was a violation of Florida Statute 812.014(2C5) and transported to the Leon County Jail for booking.
